Tin Can Tourists Convention, January 1

The Tin Can Tourists organization was formed in 1919. The members did not pay dues. They pledged to help each other on the road, keep tourist camps clean, and protect the woods around the camps. They were called "Tin Can Tourists" either because they ate food from "tin cans" (some used a tin can as a hood ornament) or because of their metal "tin can" travel trailers or because they ate communal

suppers off their "tin pans" (metal dinner plates).

Or perhaps because many drove Model T's, known as "Tin Lizzies."

The Arcadia City Mobile Home Park on U. S. Highway 17 (South Brevard Avenue) began as a camp for motorists who lived in tents or homemade

"motor homes."

Tin Can Tourists Convention, January 1

In 1924, it was established as the Arcadia Tourist Camp. F. E. Hanson served as a manager and had a service station and grocery store for their convenience. It became a local garage but was demolished when U.S. Highway 17 was widened to four lanes.

The Tin Can Tourists of the World met for their annual convention on New Year's Day in Arcadia from 1924 until 1931 when the convention moved to Sarasota. However, the Tin Can Tourists continued to meet at the Arcadia Tourists Camp for their "winter homecoming"—or Christmas holidays.

The Society owns five panoramic photographs of early conventions: four are on display in the Ingraham House Museum and one at the DeSoto County Chamber of Commerce. We are also grateful for recent donations of newspaper clippings and other documents about the organization when they were in Arcadia from Forrest and Jeri Bone, who renewed the club as "an all-make-and-model vintage trailer and motor coach club in 1998" (www.tincantourists.com).

Pearl Harbor Day Commemoration Ceremony

We are grateful to the American Legion for holding their Pearl Harbor Day Commemoration Ceremony at 10 a.m. on the 1924 (newly restored) Peace River bridge on Dec. 7. Legionnaires James Adkins, Ron Jones, and Carl Turner served as the honor guards and Adkins addressed the crowd. After the Honor Guard fired a salute, Society Member Lou Towne joined James O'Leary as the World War II veterans who tossed the symbolic flower wreath into Peace River to remember the 2,403 who died when the Japanese attacked Pearl



Happy Dr. Martin Luther King, Jr. Day!

As we celebrate Dr. Martin Luther King, Jr. (1929-1968) on Jan. 18, 2021, let us remember the number of times he visited our state as well as the streets, libraries, schools, and other locations that are named for him. His words ring in the Florida State Archives in a copy of a telegram sent via Charles Kenzie Steele (1914-1980) to the eight Florida A & M University students who were jailed in Tallahassee in 1960 for trying to integrate a lunch counter. The Archives note, "King calls the students courageous and tells them that '[g]oing to jail for a righteous cause is a badge of honor and a symbol of dignity' (http://www.floridamemory.com/items/show/329141).

Member Profile: Max Fitzpatrick

A retired farmer, educator, and County Fair administrator, Max Fitzpatrick is a snowbird with plenty of experience in historic preservation. A member of the Society for more than a decade, he is also a member of the Johnson County, Indiana, Historical Society, established in 1976. He serves as Johnson County's Historian, a position appointed by the Indiana Historical Society and the Indiana Historical Bureau (https://indianahistory.org/across-indiana/hometown-resources/county-historians). The Society nominated him to a renewable three-year term that he has held for 25 or 30 years. He said, "It's hard to keep count when I'm having so much fun."

Founded in 1931 by the Alexander Hamilton Chapter of the Daughters of the American Revolution, the Johnson County Museum of History in Franklin first used a room in the southwest corner of the courthouse. The DAR's Museum Committee managed the collection that was moved in 1963 to a home donated to the Museum. The Historical Society and Johnson County purchased the former Masonic Temple and moved the museum there in 1991 (https://co.johnson.in.us/jcmuseum)

Max's late wife Lois Rachel Fitzpatrick (1934-2010) worked as a volunteer, including assisting the curator, from 1979-2009. Lois and Max also volunteered their time and talents in DeSoto County, and we are grateful that Max continues to do so. He also established the Retired Ranchers' and Farmers' Club, and members from 13 states learn about Arcadia and DeSoto County. The Club suspended activities this season because of the COVID-19 pandemic.



In Memory of James Westberry


The son of Walter H. Westberry and Mildred Williams Westberry, James "Jimmie" Waldron Westberry, Sr., was born in 1935 and died on Dec. 20, 2020. He graduated from DeSoto County High School in 1953 and owned DeSoto Auto Repair and citrus groves. He served on the DeSoto County School Board for 36 years.

A member of the Arcadia Church of God, he served as clerk for 28 years and as a member of Pentecostal **Theological Seminary's Board of Directors. He was a** member of the Arcadia Rotary Club, Bulldog Boosters, DeSoto County Peace River Valley Citrus Growers, Florida Farm Bureau, Florida National School Board Association, and the Historical Society.

He served on the Society's Board of Directors and traveled to Tallahassee with his wife and granddaughter to lobby for the grants to restore the John Morgan Ingraham House. Later, he and Bebe Bradbury co-signed the loan needed to build the John Morgan Ingraham Seed House. He often set up the "washpot" for washing clothes at Pioneer Day sharing his memories of growing up in our county, and he portrayed "the banker" in early Pioneer Day skits. He was a faithful member and always brought his warm smile and kind words to every meeting.
